Chair Theobalds presided. Chair Theobalds and Commissioners Dinallo, Kathuria, Melvin, and Thomas participated from NYSIF's New York City office, and Commissioners Brabham participated from NYSIF's Albany office. A quorum was announced and maintained throughout.

**1. Election of Chair and Vice Chair**

Chair Theobalds turned the meeting over to Chair of the Governance & Legal Affairs Committee Scott Melvin to preside over the election of the Chair and Vice Chair of the NYSIF Board of Commissioners.

Commissioner Melvin opened the floor to nominations for Chair of the Board. Commissioner Dinallo nominated Commissioner Theobalds, who accepted the nomination. No other nominations were made. Commissioner Melvin called for a vote. The Board unanimously voted to elect Commissioner Theobalds as Chair of the NYSIF Board of Commissioners. The vote: Commissioner Brabham – yes; Commissioner Dinallo – yes; Commissioner Kathuria –

yes; Commissioner Melvin – yes; Commissioner Theobalds – yes; and Commissioner Thomas – yes.

Next, Commissioner Melvin opened the floor to nominations for Vice Chair of the Board. Commissioner Theobalds nominated Commissioner Dinallo, who accepted the nomination. No other nominations were made. Commissioner Melvin called for a vote. The Board unanimously voted to elect Commissioner Dinallo as Vice Chair of the NYSIF Board of Commissioners. The vote: Commissioner Brabham – yes; Commissioner Dinallo – yes; Commissioner Kathuria – yes; Commissioner Melvin – yes; Commissioner Theobalds – yes; and Commissioner Thomas – yes.

**2. Report of Executive Director & CEO**

In the absence Executive Director & CEO Gaurav Vasisht, Chief Operating Officer, Insurance Operations Peter Cusick delivered the executive report. He stated he would defer his report to Executive Session, subject to a motion to enter Executive Session.

**3. Report of Acting General Attorney**

Acting General Attorney David Wertheim stated he would defer his report to Executive Session, subject to a motion to enter Executive Session.

**4. Report(s) of Standing Committees**

Budget & Audit Committee

Commissioner Thomas, as Chair of the Budget and Audit Committee, reported that the committee met on February 12, 2026, to receive the year-end financial report. She asked Chief Financial Officer William Gratrix to provide the financial report to the full Board.

Mr. Gratrix reported on the Workers' Compensation Fund's 2025 financials. The financials showed a steady stream of earned premium, a moderation in underwriting results, a reduction in realized gains from fewer sales of common stocks, and an increase in provisions for potential doubtful accounts. As a result, net income decreased from \$794 million in 2024 to \$578 million in 2025.

For the Disability Benefits and Paid Family Leave Fund, statutory pricing and risk pool adjustments resulted in reduced net income from \$39 million in 2024 to \$26 million in 2025.

#### Investments Committee

In Commissioner Ourlicht's absence, Chair Theobalds reported that the committee met on February 4, 2026. The committee received updates on the private market funds and upcoming procurements. There were no compliance issues to report for the month of January.

The Chair also reported on NYSIF's MWBE Investment Symposium, which was held on February 9, 2026. The symposium was a great success, and attendees praised the event. He thanked Commissioner Thomas for her leadership in making this year's event such a success, and thanked Melissa Jensen and NYSIF staff for all their hard work in organizing the event.

#### Property & Administrative Services Committee

Chair Theobalds, as Acting Chair of the Property & Administrative Services Committee, reported the committee met on February 3, 2026, to receive updates on NYSIF's various real estate projects.

### **5. Motion to Accept Consent Agenda**

Upon a motion by Commissioner Kathuria, duly seconded by Vice Chair Dinallo, the Board unanimously voted to accept the minutes of the January 28, 2026, Board meeting and have them filed as the official minutes of the Board, as well as to accept the written reports as submitted.
