She also developed and ran a specialty business unit focused on providing philanthropic consulting services to clients. Ms. Gelfand also previously held roles at Duke University where she oversaw strategy and operations for an accelerator program that produced research and provided consulting services to a global network of 50 nonprofit and forprofit healthcare-focused social enterprises.
